The Clerk highlighted that Academy Articles of Association date from 2011 and do not reflect latest Government academy structures notably that Governors are not also members and that employees, other than the senior executive leader of the Trust (Headteacher), are not Governors. Operationally the GB is bound by its Articles. Rob Stokes indicated that members could elect to adopt up-to-date Articles of Association for implementation in conjunction with solicitors. The Clerk shared a conversation with the Diocese in which it recognised anomalies in the Articles but indicated that, as the school is seeking new partnerships, change could be aligned with a new MAT structure. Auditors suggested that St Matthias works towards the appointment of all non-governor members within 3 years.
